



2024 MCLEAN COUNTY FAIR 4-H CAMPING RULES AND APPLICATION

1. All overnight camping applications must be approved by the McLean County Fair (MCF) management. The approval notice must be displayed on the camping unit at all times while on the Fairgrounds.
2. All campers under the age of 18 sleeping overnight on the Fairgrounds between 5 PM Tuesday, JULY 23rd through 8 AM Sunday, JULY 28th, 2024, must have their parents complete a release of liability.
3. All minors must be under the direct supervision of a parent in attendance. The ratio is One (1) adult to Four (4) youth campers. **The supervising adult must be the parent of one of the campers.** All parents will be required to list the names of the campers for which they will be responsible. Any updates are to be communicated and approved by the MCF management prior to camping being allowed.
4. An **\$20 per night** fee will be assessed for each camping unit placed on the grounds. Registration and payment is required by the day of arrival. The rental fee provides access to 30 amp electric service, water hookup, and access to the dump station.
5. Campers must wear the designated camping wristband provided at check-in at all times.
6. Camping units are allowed to park in the designated camping area starting on Tuesday July 23rd at 5 PM. No vehicles or camping units are allowed on the fairgrounds prior to that date and time unless approved by MCF management. Only one vehicle per camping unit is allowed per camping space for the duration of the fair.
7. Campers are responsible for keeping their campsite neat and clean. All trash and waste must be disposed of in an approved manner. Dumping black/gray water directly on the ground is prohibited.
8. No alcoholic beverages, narcotics, tobacco, or illegal substances of any kind are permitted on the fairgrounds.
9. No fires of any sort are allowed.
10. Campers are responsible for providing all electrical cords. Extension Cords used to distribute power to electrical machines shall be rated 20 amps minimum and must contain ground wire. Cords not meeting these requirements shall be disconnected immediately from the power supply and required to meet the standards before reconnecting.
11. No modifying of electrical outlets is permitted. No electrical cords shall cross any roadways.
12. A curfew of 11 p.m. will be enforced to create 'quiet hours' between 11 p.m. - 6 a.m.
13. Overnight security is not provided or implied by this agreement. Overnight security will enforce curfew and is onsite to protect MCF property and equipment. MCF is not liable for damage to Camper's property.
14. **No dogs or pets are allowed on the fairgrounds.**
15. Anyone who violates the camping rules or displays undesirable conduct, as determined by the MCF management or security personnel, will be required to leave the Fairgrounds that night. The supervising parent of the released Camper shall meet with the MCF Manager the next business day.
16. Noncompliance with these rules may result in the disqualification of any exhibits and forfeiture of all ribbons, premiums, and awards.

I hereby request authorization to park the camping unit listed below on the Fairgrounds during the McLean County Fair. I have read the Camping Rules and understand I am responsible for the conduct of anyone who stays in my camping unit. I agree to follow the Camping Rules and cooperate with McLean County Fair personnel in enforcing these Rules in my camping unit.
